All participants were informed that the replies to their respective queries will also be shared through e-mails as well as uploaded on the web portal of DDCD and also on the e-procurement portal of Delhi Government.

The Committee also persued the requests of various stakeholders for extension of the bid submission start date as well as last date of submission of bids. After perusal, it was decided that the bid submission may start from 08.6.2022 from 12.00 noon onwards instead of 30.5.2022. The last date and time of submission of bids may also be extended to 20.6.2022 upto 3.00pm instead of 06.06.2022.
